Brokerage compensation is part of your insurance premium. For your benefit, we have listed below the Insurers for all lines of business that we represent and have included the range of compensation each provides as a percentage of your overall premium.

Aviva * 12.50% to 20%

Yarmouth * 12.5% to 20%

Intact * 10% to 20%

Axiom * 10% to 20%

Jevco 5% to 12.5%

Max * 20%

Travelers * 12.5% to 20%

Definity * 10% to 20%

Travelers Essential 12.5% to 20%

Echelon * 12.5%

Facility 7.5% to 11% (commission capped at \$370)

Our Insurance Brokers also deal with a number of MGA's or Managing General Agents whose commissions range from 12.5% to 20%.

The commission percentage is paid annually for both new business and renewals.

Should there be an increase in the commission schedule we received from your insurer, or, any other material change that affects compensation arrangements, we will notify you.

In order for us to maintain strong relationships with quality insurers, we work with each to provide the type of business they desire. The insurers with an asterisk noted above recognize our efforts through a Contingent (Profit) Commission contract. Payment of this Contingent (Profit) Commission may depend on a combination of growth, profitability (Loss ratio), volume, retention and increased services that we provide on behalf of the Insurer.
